Mary Ann Davis Pharmacy Director

Mary Ann Davis, featured speaker at the 2008 Linly Heflin Scholarship Luncheon, bubbles with enthusiasm over her chosen career in pharmacy. Her favorite subjects in high school were math, biology, and chemistry, and she always enjoyed "mixing things together". She started working in a pharmacy in her hometown of Leeds at the age of sixteen. She liked her job there so much that she decided that she wanted to become a pharmacist. An outstanding student, she graduated as Valedictorian of her Leeds High School class. Offered a full scholarship to the University

of Montevallo, she opted to go to UAB instead, in order to get the preparatory courses that were necessary for pharmacy school. Her parents supported her dreams of a college education, but were not able to help her financially. Mary Ann was able to cover her expenses with the help of a Linly Heflin scholarship, student loans, and through continuing to work twenty hours a week at a drug store. After two years at UAB, she was accepted into the Samford Pharmacy School, and graduated in 1992. After working for several drug stores in the Mtn. Brook and Vestavia areas, she became employed at the Wellness Pharmacy in Homewood. In 2004 she became the Director of Pharmacy, the position she presently holds. The Wellness Pharmacy provides traditional over-the-counter medications and dietary suplements. In addition, they provide made-to-order prescriptions for individuals. In this respect, Wellness re-

sembles an old-time apothecary. Pharmacists in their well-equipped labs actually manufacture the various medications and nutritional supplements that are prescribed by physicians from all over the city. The pharmacy is licensed to do business in 42 states, and fills a tremendous number of mail orders, since compounding services are not readily available in many areas of our country. Mary Ann is proud of the fact that the Wellness Pharmacy provides specialized care for every individual. She and the other pharmacists offer free consultations to patients with allergy problems. Children with autisim often have severe allergies, and their parents receive expert counseling in regard to medications and supplements.

As Director of the Pharmacy, Mary Ann is in charge of the hiring, training, and scheduling of the company's forty employees, which include fourteen pharmacists. She also has the responsibility of supervising the work carried on in the labs, filling in as a lab technician when necessary. She monitors the various licenses and regulations pertaining to the pharmacy. Much of her time is spent in talking to various doctors, nurses, and customers who request consultations.

Mary Ann finds her job to be challenging, time-consuming, and occasionally exhausting, yet she describes her work as satisfying, unique, and tremendously rewarding. She regards pharmacy as an ideal career choice for women. She believes that women are more patient and caring in dealing with individuals. The pay scale is attractive, and the work

schedules are flexible, which is a huge advantage for women with children at home. She is grateful that the business is closed on week-ends, so that she and her husband, Frank, can spend quality time with their two sons, nine-year-old Jackson, and five-year-old Grayson.

The President of Auburn University Speaks to the Linly Heflin

Dr. Jay Gogue, the President of Auburn University, was the main speaker at the May meeting of the Linly Heflin Unit. He gave a brief history of Auburn, explaining that it was the first "land-grant" college in the South, and therefore its mission was to teach agriculture, military tactics, and the mechanical arts as well as classical studies so that members of the working classes could obtain a liberal, practical education. At that time a college education was usually reserved for the upper classes and

focused on Latin, Greek and the Classics. 75% of the population depended upon agriculture for a living, versus 17% today. In 1892, Auburn became the first state university to admit women. (That was also the year that the first football

game was played at Auburn.) The University has grown to a campus of over 24,000 students, 52% of which are women. The overall goal of the school is to give students abilities that will help them to be successful in life. A recent survey of college graduates, done five years after graduation, found that 88% of lvy League graduates said that they would choose the same college again, and 96% of Auburn graduates said they would choose Auburn again.

Dr. Gogue ended his talk with words of appreciation to the Linly Heflin for all that they have done to further education in Alabama, noting the fact that this year twelve Auburn students are Linly Heflin scholars. The members of the Linly Heflin gave him a well-deserved standing ovation.

Sarah Wuska Former Mayor of Vestavia Hills

Sarah Wuska, former Mayor of Vestavia Hills, has led an incredibly busy and productive life. Raised on a farm in Barbour County, Sarah was the eldest of five girls. Her mother taught school part time to supplement her father's income from the farm. During her high school years one of Sarah's teachers, a graduate of the University of Alabama, so inspired Sarah that she became determined to follow in her teacher's footsteps and attend the University. Her parents heartily approved of Sarah's ambitions, but could only give moral support. Sarah found a job working for the Superintendent of Education in the nearby town of Eufala. By saving all of her earnings, she was able to enter the University right after her high school graduation. Other funding was derived from a job in the office of the Dean of Women. By going to school year-round she was able to graduate in three years,

with a degree in Elementary Education. During her senior year, she applied for and was given a Linly Heflin scholarship, which she says was a tremendous help to her.

Following graduation, Sarah married her college sweetheart, Tim, who had majored in Mechanical Engineering. The couple settled in Birmingham, and Sarah spent the next two years teaching fifth and sixth grade at Minor Elementary School. Her career as a school teacher was interrupted by the arrival of their first child. She and her husband were eventually blessed with a family of four children: two boys and two girls. When the oldest was three years old, the couple moved to Vestavia Hills, where they still reside. Sarah is a person of boundless energy, and soon became heavily involved in all of her children's activities. She served

as neighborhood chairman for the Girl scouts, assisted with Boy Scout troops, swim teams, baseball teams, and held offices in the P.T.A. As the children grew older, Sarah undertook numerous civic and community jobs. She was instrumental in getting the Vestavia Hills Library started, and served on the Library Board for six years. She was an establishing member of the Vestavia Hills Board of Education, and served on it for ten years. She served on the

Vestavia Hills City Council for four years, and then spent another four years as Mayor. During her term she helped found the Chamber of Commerce, and also initiated a transportation program for older citizens. Her volunteeer activities, which are almost too numerous to mention, include leadership positions


Dr. Andrea M.D.

The next step in her career involved a move to Tuscaloosa, where she entered a Family Practice Residency with the Capstone Program at Druid City Hospital. It was here that she met her future husband, Randy, a graduate of the U.A.B. School of Medicine, who was enrolled in the same program. The couple married in 1998, and have set up separate family practices. Randy's office is in

Trussville, while Andrea's is in the Inverness area.

Dr. Marlene Rikard, Ph. D.

Professor of History, Samford University

Marlene Rikard, who recently retired as Professor of History at Samford University, is a person of many talents and abilities. In addition to fulfilling her role as a devoted wife and mother of two sons, she has found time to pursue two different careers As an outstanding West End High School student, she was awarded a scholarship by the Linly Heflin. Since art had always been a major interest, she decided to enter Auburn University and pursue a commercial art degree. She majored in graphic design, and graduated with a BAA degree in 1960. She loved her time at Auburn, and is fiercely loyal to the school. While she was there, she met an attractive fellow graphic design student from Mobile. Marlene and Frank Rikard were married the year following their graduation. While her husband founded his own graphic design business. Marlene became the Art Editor for the Women's Missionary Union of the Southern Baptist Convention. After several years in this position, she decided to become a self-employed free-lance graphic artist. She particularly liked the flexible schedule that

her work allowed, for the needs of her family were always uppermost in her priorities. In addition to art, Marlene had always loved history. She learned of a Master's program in history that was offered at Samford and decided to enroll. Because many of the courses were offered at night, she was able to continue with some free-lance graphic art work in the day time. One of her favorite professors was Dr. Wayne Flynt. Marlene tells us that his class in The New South opened an exciting avenue of study and research that shaped her future career. In 1971 she received a Master's degree in History, and was given a job as Director of Reader Services at the Samford

University Library. In 1973 she was asked to serve as an Instructor in the Department of History. Later, at the urging of some of her colleagues, she decided to begin work on a Ph.D. at the University of Alabama. It was a rather stressful time for her, as she also continued with her teaching at Samford. At the same time that she was creating lectures, composing exams, and grading papers, she was doing research and writing seminar papers for her professors at Alabama. Her husband and sons were a great deal of help to her during this time because they took on extra responsibilities at home. All of her efforts paid off, and in 1983 she was awarded a Ph.D. by the University of Alabama.

Marlene was made a full professor at Samford and became one of the most popular teachers on campus. She founded the field of Women's History, and offered courses in American Labor and Economic History. Other courses developed by her were New South and Oral History.

Her goals were to teach her students how to learn, to broaden their understanding of the world, and to appreciate the importance of history in their own lives.

In addition to her teaching duties, she was made director of Samford's London Studies Program. From 1988 to 2000 she was in charge of every aspect of the program, from overseeing the renovation and maintenance of the physical facility to developing and administering the academic programs offered. The program became so popular that students would sleep in the halls of the school so that they could register for "The Semester Abroad" the following day.

Throughout her career, Marlene has won numerous honors and awards. In 1980-81 she was given The American Association of University Women Fellowship, which helped fund her expenses for the Ph.D. program at Alabama. Other awards include: The Southern History Award, Moore Memorial Scholarship, Frank L. Owsley Award, the coveted national John E. Rovensky Fellowship in Business and Economic History.

the Award for Alumni Achievement in the Humanities from Auburn University College of Liberal Arts, and the Macon Award for Outstanding Teaching, Samford University, 2005. She has written prolifically, and published many professional papers. As a professor, her goals were to teach her students how to learn, to broaden their understanding of the world, and to appreciate the importance of history in their own lives. She always urged students to live up to their highest potential.

This past May, Marlene formally retired from teaching, but she will not remain idle. "I hope that I will be blessed with good health and self-discipline in retirement to complete some of the unfinished research projects that I have planned, and still find time for travel, adventures with friends, and some games of tennis played in the daytime rather than after work."


by the school. She also received a special Linly Heflin Medical School Scholarship, which she says was a great help toward the staggering cost of books and equipment.

For the present, however, Erica is extremely busy with her internship, which requires eighty hours of work each week. When she is on call, she often works for thirty hours at a time, with no sleep. In spite of these hardships, Erica truly loves her chosen career.
